WHAT YOU NEED TO DO: Call & make an appointment for a specific date & time.

WHAT YOU MUST BRING: Marriage License, Certificate & at least 2 witnesses (18 yrs. old or older)

****FEE REQUIREMENT FOR IN CHAMBERS WEDDINGS AND SOME OUT OF CHAMBERS WEDDINGS:** SB 391 requires the payment of a \$25.00 fee for all marriages performed at certain times by circuit judges. This fee must be paid prior to the wedding. Please ask the judge=s office about this fee and where to pay it when scheduling the wedding.

All judges who perform weddings on evenings & weekends are subject to availability & you must make arrangements for the location. Fees charged for ceremonies outside chambers or after hours will vary (up to \$100.00). If there is no time listed in either the In Chambers or Outside Chambers column, then that judge does not perform weddings in that category. Court holidays will be scheduled as “outside chambers” weddings. Unless prior arrangements are made, you must provide your own witnesses (18 or older).
